Issue: Bioethics, Transhumanism, Vaccines, towards a New Deal

Since the turn of the century, Morocco has seen significant improvements in its healthcare with major achievements taking place like the introduction of a mandatory healthcare plan (AMO) in 2005 which allowed to provide healthcare coverage to workers both in the public and private sectors. Whilst our state has been making steady improvements when it comes to healthcare, we still have some large holes to fill, and we are still far from being one of the world's most advanced countries when it comes to healthcare.

Bioethics is a topic on which our country has some strong opinions. We are a conservative country when it comes to this topic due to our religion. The official religion of our state is Islam and around 99% of our population is Muslim.
